
4. The officials may be relieved of their duties and directed to report to their new establishments immediately, but not later than one month from the date of issue of this order. Availability of vacancy may please be confirmed by the concerned establishment prior to movement of officials. **The promotion will be effective from the date of charge assumption in the higher grade of AO.** The date on which official assumes duty as Administrative Officer, should be communicated to this HQ (DGQA/Adm-6A, Adm-6B, Adm-7A and Adm-10 separately), along with necessary DO Part-II, by the concerned HoEs on occurrence by the fastest means.

5. In case an official refuses to accept promotion, his/her unconditional '**Unwillingness**' for the same and reasons thereof, should be obtained in writing and forwarded to DGQA/Adm-6A within 10 days from receipt of this order, through the concerned HoE with due recommendation of respective ADGsQA/Offg ADGsQA for further action.

6. The reason for foregoing promotion should invariably be on very valuable/compelling grounds, along with relevant documents to support the ground(s) given by the official with due recommendations of concerned HoEs and his/her respective ADGsQA/Offg ADGsQA. In case where the reason(s) adduced by the official for his/her refusal for promotion are not acceptable to the Appointing Authority, the Appointing Authority may enforce the promotion of the official and in case the official still refuses to accept the promotion, then disciplinary action can be initiated for such disobedience as per rules in vogue.



7. Action on initiation/endorsement of APAR/NIR/NIC, if due, will be completed in compliance to the extant policies and a confirmation regarding the same should be forwarded to HQ DGQA/APAR Cell by the Concerned HoEs.
8. The above mentioned officials are entitled to TA/DA and joining time, as admissible under the existing rules and they will exercise their option for fixation of pay on promotion, within one month from the date of promotion, as per extant rules.
9. Tech Dtes are requested to disseminate this order to all concerned establishments under their administrative command and control for implementation.
