


- Consequent on empanelment in the Revised Select List for the vacancy year 2024, the promotion order in respect of Shri Sudhakar Sharma, JE(QA) and Shri Varun Singh, JE(QA) [Ser No. 8 & 10 respectively of Para 2 above], are required to be issued. The promotion will have only prospective effect. The above individuals will be offered promotion subject to availability of vacancies.
- The promotion orders in respect of the remaining officials (Ser Nos.1 to 7, 9 and 11 of Para 2 above) have already been issued by DGQA/Veh-1. Hence, no fresh promotion orders in respect of these officials are required to be issued.
- Before the above individuals are offered promotion, it may be ensured that no disciplinary/vigilance case is pending against them.

The promotion order based on above select panel must clearly mention this stipulation.
