3. The promotion will have only prospective effect from 01 Jan 2026 or date of charge assumption whichever is later.
4. It may be ensured that no disciplinary/ vigilance case is pending against the above individuals before they are offered promotion.
5. The receiving establishment should confirm availability of vacancy within two days from the date of issue of this letter to the concerned establishment. The move of above mentioned individuals shall be completed before 15 Jan 2026. However, endeavor should be made that individual (if desired) shall join duty on 01 Jan 2026.
