PERIODICAL REVIEW OF PERFORMANCE OF GOVERNMENT SERVANTS UNDER
FR-56(J) & RULE 48(1)(B) OF CCS (PENSION) RULES, 1972

1. Reference this office note number A/97626/FR-56(j)/DGQA/Adm-6A/32A dated 01 Jun 2016 on the above subject and also note dated 02 Jul 2019 for Qtr ending Mar 2020.

2. In terms of FR-56(j) and Rule 48(1)(b) of CCS (Pension) Rules, 1972, performance of Group 'A' and 'B' officers are required to be reviewed as per following conditions :

FR-56(j) : Officers who entered service before 35 years of age and have attained 50 years of age; or on attaining 55 years of age in case the officer entered service after 35 years of age.

Rule 48 (1)(b) of CCS (Pension) Rules, 1972 : Officers who have completed 30 years of qualifying service.

3. As per Government instructions, review under above provisions of FR-56(j) and Rule 48(1)(b) of CCS (Pension) Rules, 1972, for retention in service or otherwise should be undertaken six months before their attaining the age of 50/55 years for Group 'A' and 'B' posts or completion of 30 years of service whichever is earlier.

4. All Tech Dtes are therefore, requested to direct the establishments under their control to forward such cases in the format enclosed as Appx 'A' & 'B' in respect of Group 'A' officers to this section alongwith a certificate by the Head of the Establishment as mentioned below:

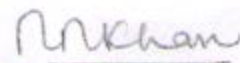
"Nothing adverse has been noted from the entries available, if any, in the Service Book and personal case file of the officer and no vigilance case is pending/contemplated against the officer during the entire service in DGQA".

5. In case, the officer has something adverse with reference to the para 4 above, the complete details of the case may also be forwarded for submission of the same to the Competent Authority. A Certificate may also be furnished regarding the punctuality and any kind of leave taken without permission during the entire period of service.

6. In view of the above, it is once again requested that all such cases of concerned Group 'A' officers of the establishments under your administrative control and command, who will be attaining the age of 50/55 years or completing 30 years of service, whichever is earlier, during the Quarter ending Jun 2020 be forwarded to this HQ on the proforma alongwith recommendations of the concerned HoE as per Appx 'B' attached herewith by 21 Oct 2019 for further action at our end please. A certificate has to be given by the concerned ADGQA stating that cases of all Group 'A' officers who are due for review upto 30 Jun 2020 have been submitted and no old case is pending with them till Quarter ending Jun 2020.

7. Further, it is stated that the statement of case are not receiving before due date in most of the cases. In this regard, it is intimated that as per the latest Government instructions on the subject, review of cases should be taken on priority. Any lapse, if any, to be seriously viewed by the authority and responsibility to be fixed for not sending the case for review to this HQ timely. It is further clarified that old cases shall not be considered without the approval of DG, DGQA.
